After 33 years in power, former President Ali Abdullah Saleh formally stepped down in February 2012 when Abdo Rabbo Mansour Hadi, running as the sole consensus candidate, was elected president in a vote generally considered to be free and fair. During the subsequent transition process, implemented through the framework of the Gulf Cooperation Council (GCC)-brokered initiative, elements of the transitional National Consensus Government sought to expand political participation to formerly excluded groups, such as women, youth, and minorities. Despite progress in security sector reform, a key component of the overall transition, the transitional government did not exercise full control over the security forces due to competing family, tribal, party, and sectarian influences. Security forces, some affiliated with the former regime, operated outside the law and committed human rights abuses. The most significant human rights problems were arbitrary killings and other acts of violence committed by the government and various entities and groups, disappearances and kidnappings, and a weak and corrupt judicial system that did not ensure the rule of law. Other human rights problems included torture and cruel, inhuman, or degrading treatment or punishment; poor prison conditions; arbitrary arrest and detention; lengthy pretrial detentions; some infringements on citizens privacy rights; some limits on freedom of speech, press, assembly, association, religion, and movement; lack of transparency and significant corruption at all levels of government; violence and discrimination against women; violence against children; reported use of child soldiers by security forces, tribal groups, and other informal militias; discrimination against persons with disabilities; discrimination based on race, gender, and ethnicity; restrictions on worker...
